No. 5/146/2011-FD(TAX): Whereas the Government has enhanced the tax rates on the item "Petrol including Motor spirit (excluding aviation turbine fuel/spirit/gasoline)" from 20% to 25% and on the item "Diesel Oil (High Speed Diesel)" from 13.5% to 14.5% vide Notification No. 5/146/2011-FD(TAX) dated 16th February, 2016;

Whereas the new tax rates were published in the Official Gazette of Manipur vide Notification No.1192 of March 2, 2016;

Whereas the Indian Corporation Ltd vide their representation intimated that the new taxes were incorporated in their SAP system only on 13.3.2016 due to delay in receipt of the Official Manipur Gazette No.1192 dated 2nd March, 2016 and requested for effecting the new tax rate from 13.3.2016;

Whereas the matter was minutely examined by the Government in the Finance Department and considered it for change of the effective date of the new tax rates to 13.3.2016;

Now, therefore, the Governor of Manipur is pleased to order that the new tax rates on "Petrol including Motor spirit (excluding aviation turbine fuel/spirit/gasoline)" and "Diesel Oil (High Speed Diesel)" shall be effective w.e.f. 13th March, 2016.
